#### Who is the controller of your personal data?

# Who is the Data Protection Officer at das-Nano and how can you contact this person?

The Data Protection Officer is the person responsible for protecting the fundamental right to personal data protection at das-Nano and is in charge of the compliance with data protection regulations. You can contact das-Nano's Data Protection Officer at: <u>dpo@das-nano.com</u>

#### What does das-Nano use your personal data for?

das-Nano processes your personal data for the purpose of managing the business relationship the entity maintains with you due to your status as a representative of a das-Nano's customer or supplier, or as a contact person.

#### Why does das-Nano use your personal data?

The legal basis that allows das-Nano to process your personal data is the execution of a contract or a business relationship in which you are a party.

das-Nano must also comply with the legal obligations imposed by law and, among them, by the current personal data protection regulations.

#### How long will das-Nano keep your personal data?

das-Nano will keep your personal data throughout the validity of the contractual/business relationship in which you are a party. Once the contractual relationship is finalized, das-Nano will keep your personal data blocked during the statutory limitation periods, generally 10 years, and will then destroy your data.

In the case of business relationships, your data will be destroyed once such relationship has ended.

#### To whom will das-Nano communicate your data?

das-Nano will not transfer your personal data to third parties, unless it is bound to do so by a law or if you have previously agreed to do so with das-Nano.

In order to be able to provide you with an adequate service and manage the relationship that das-Nano maintains with you, you can find below a list of categories of companies that process your data on behalf of das-Nano as part of the provision of services it has contracted.

das-Nano also informs that, for the same purpose as indicated in the previous paragraph, certain companies that provide services to das-Nano could access your personal data (international data transfer). These transfers are made to countries with a level of protection comparable to that of the European Union (European Commission adaptation decisions, standard contractual clauses as well as certification mechanisms). You can request limitation on the processing of your data in the following cases:

• While checking your dispute about the accuracy of your data. • When the processing is illegal, but you oppose to the deletion of your data.

• When dasGate does not need to process your data but you need them in order to exercise or defend your claims.

• When you have opposed the processing of your data for the

purpose of fulfilling a mission that is in the public interest or to

satisfy a legitimate interest, while verifying whether the legitimate reasons for the processing prevail over yours.

**Data portability** You will be able to receive, in electronic format, the personal data you have provided to us, as well as and to transmit it to another entity.

If you consider that das-Nano has not processed your personal data in accordance with the regulations, you can contact das-Nano' Data Protection Officer at dpo@das-nano.com.

You can also lodge a claim with the Spanish Supervisory authority (www.agpd.es).

In order to exercise your rights, accompany your request with a copy of your National ID or equivalent document proving your identity.
